Statement of the Joint session of the Russian-Tunisian business council (RTBC)

Within the framework of: increasing bilateral trade and investment flows between Tunisia and Russia; bringing together the Tunisian and Russian business communities; and finding new opportunities of cooperation and partnership between the two countries, the Tunisian-Russian Business Council agreed on the following:

- 1. To continue expanding the membership base of the Russian and Tunisian members of the RTBC;
- 2. To organize on a regular basis the placement of information on tenders and competitions held in Russia and Tunisia on the website of the Russian-Tunisian Business Council;
- **3.** To prepare and organize the next joint session of the Russian-Tunisian business council in Moscow, March 2011;
- 4. To hold during the same period of the organization of the next joint session of the Russian-Tunisian business council (March 2011) a seminar about Doing Business with Tunisia and an exhibition of Tunisian products in Moscow with the support of the Tunisian Embassy in Moscow, Foreign Investment Promotion Agency (FIPA) and the Tunisian Center of Promotion of Exports (CEPEX).
- 5. To assist in developing program according to the Cooperation Agreement between the Chamber of Commerce and Industry of the Vladimir-region and the Union regional of Industry, Commerce and Handicrafts of Tunisia in Bizerte.
- 6. To assist in developing program according to the Cooperation Agreement between the Moscow Entrepreneur Association (MEA), and the Chamber of commerce and Industry of city of Tunis (CCI of Tunis).

- 7. To assist in developing program according to the Cooperation Agreement between the Moscow chamber of handicrafts and Federation of Tunisian handicrafts (UTICA).
- 8. To prepare and carry out the presentation of free trade zone and technopolises of Tunisia in the frame of the All-Russian exhibition-forum "GOSZAKAZ-2011" (23-25 March, 2011, IEC "Crocus-Expo", Moscow).
- 9. To organize the collective exposition and to carry out the presentation of Tunisian companies in the frame of the All-Russian exhibition-forum "GOSZAKAZ-2011" (23-25 March, 2011, IEC "Crocus-Expo", Moscow).
- **10.** To prepare and organize the official visit of Altai-region to Tunisia in 2011-2012.
- 11. To prepare and organize the official visit of Tunisian delegation to Altai-region in 2011-2012.
- 12. To explore the question about the organization of International exhibition of innovates of Maghreb countries in Tunisia in 2011-2012.
- 13. To improve the plan of joint events according to results of bilateral negotiations.
